Board of Transportation Meeting

June 6, 2013

Call to Order

Chairman Curran called the meeting of the Board of Transportation to order at 9:23 a.m. Thursday, June 6, 2013 in Raleigh, North Carolina with the following members present:

Invocation

The invocation was offered by Board Member Tulloss.

Swearing-In of New Board Members

The Oath of Office was administered by the Honorable Paul Newby to new Board Members Crawford and Wetmore.

Approval – Minutes of the May 2, 2013 Board Meeting

The minutes of the May 2, 2013 Board of Transportation meeting were unanimously approved upon a motion by Board Member Overholt, which was seconded by Board Member McQueary.

Ethics Statement

Chairman Curran read the Ethics Statement advising any Board Member that may have a conflict of interest or appearance of conflict to abstain from participation in that particular item and to file the proper paper work with the Secretary to the Board.

Secretary's Remarks

Secretary Tata welcomed everyone to the meeting. He noted that last month he gave a brief presentation regarding the Strategic Mobility Formula. He is giving similar presentations to groups throughout the state. He reported that the bill is progressing through the General Assembly. It passed the House and is now working its way through the Senate.

Secretary Tata announced that under Governor McCrory's focus on education, economy and efficiency, one of the Department's major goals is to better leverage our transportation infrastructure to support economic growth. The Secretary was pleased to report that the Council of State gave the go ahead for a lease agreement between the State Ports Authority and Enviva Holdings, LP, that could allow for construction of a wood pellet export facility at the Port of Wilmington. This is great news for North Carolina in terms of jobs and economic investment. The agreement could bring an estimated \$2 million annual investment and \$1.25 million in annual revenue, along with about 70 new jobs and at least 80 indirect jobs.

Enviva is a manufacturer and supplier of wood pellets to the United Kingdom and European Union. If built, the facility would receive, store, and load wood pellets for export to Europe to be used as a renewable energy source. U.S. production of wood pellets is expected to increase greatly. Four years ago we were at 3 million tons, and we're expected to be at 10 million tons by 2015.

Secretary Tata announced that we are officially in hurricane season, which began June 1st. The Department is already taking steps to make sure we are as ready as we can be, including a hurricane preparedness exercise last week. The exercise included all NCDOT units that would be involved in response and recovery operations.

The Secretary also announced that the Department recently completed the I-95 Economic Assessment that was conducted at the direction of the General Assembly. Four public meetings were held in communities along the I-95 corridor to share findings of the assessment and where the Department will go from here. The assessment was conducted and prepared by Cambridge Systematics of Atlanta and was guided by an advisory group made up of key stakeholders. The final

report will be presented to the General Assembly at the end of June. The Legislature will then direct the Department on how to move forward.

Secretary Tata shared information on bridge safety in North Carolina in wake of the recent accident in Washington State where a truss bridge collapsed after being hit by a truck. The Department continues to emphasize that NC bridges are safe and that each bridge is inspected at least every two years. The bridge program emphasizes rehabilitating and preserving bridges, not just replacing them. This approach helps save money and extends the life of the existing bridges.

The Department has invested \$450 million in state funds over the past two years to replace, repair or preserve more than 1,000 bridges across the state with a focus on addressing those that are structurally deficient. Proposed state budgets include about \$300 million to continue the program over the next two years. The total estimated cost to replace all of North Carolina's substandard bridges is about \$16 billion. Safety is always the number one priority, and the Department will continue to focus on maintaining and improving the bridges.

Secretary Tata noted that Click It or Ticket is celebrating its 20th anniversary. For the past two decades, the initiative has played a tremendous role in increasing our state's seatbelt usage and has dramatically reduced the number of crashes, injuries and fatalities involving unbelted passengers. Click It or Ticket started in North Carolina and has now grown into a national initiative and a model for safety awareness and enforcement campaigns. The success of Click It or Ticket is a true testament to the work of the Governor's Highway Safety Program and others in the Department.

The Secretary updated the Board on the Division of Motor Vehicles. There have been five additional DMV offices offering Saturday hours for the convenience of our customers. The locations are located in Sylva, Morganton, Troy, Smithfield, and Shallotte. Since offering expanded hours on Saturday, 4,000 licenses and ID cards have been issued. Last Saturday, 640 transactions were conducted at the 19 driver license offices that offer expanded hours.

Legislative Update

LaNica Allison, Deputy Secretary for Intergovernmental Affairs and Budget Coordination, provided a Legislative Update. She gave an overview of House Bill 817, Senate Bill 402, Senate Bill 411, and House Bill 10.

Update on the P3.0 Workgroup Efforts for the Strategic Mobility Formula

Don Voelker, Director of the Strategic Prioritization Office of Transportation (SPOT), provided an update on SPOT's role in implementing the Strategic Mobility Formula. He noted clarifications in the last 30 days to the proposed legislation.

High Impact Projects

Bobby Lewis, Chief of Staff, presented information to the Board regarding the major high impact projects greater than \$20 million scheduled for June 2013 – May 2015. He requested the Board members provide comments as to how they would like this information presented to them each month.

Ecosystem Enhancement Program Biennial Budget

Debbie Barbour, Director of Preconstruction, presented the Ecosystem Enhancement

Program's biennial budget to the Board. The staff recommended approving the EEP biennial budget.

A motion was made by Board Member Collett, which was seconded by Board Member Palermo, to approve the EEP budget. A copy of this item is made a part of the record of this meeting and is located on page 546 of the minutes.

Approval of Agenda

A motion was made by Board Member Palermo, seconded by Board Member Kernea, to approve the agenda items with corrections and handouts, excluding agenda items C, D, E, H and L, as they are consent items and require no Board action.

Board Member Burns abstained from voting on specific items. Board Member Collett abstained from voting on all agenda items.

Program Description

The NCDOT Division of Bicycle and Pedestrian Transportation and the Transportation Planning Branch created an annual matching grant program – the Bicycle and Pedestrian Planning Grant Initiative – to encourage municipalities to develop comprehensive bicycle plans and pedestrian plans. This program was initiated in January 2004 and is currently administered through NCDOT-DBPT.

For the 2013 grant cycle, a total of 12 applications were received. New to the grant program this year, five applications were for joint bicycle and pedestrian plans; two applications were for bicycle plans and the remaining five were for pedestrian plans. The Division has recommended 10 plans for award for the 2013 cycle. Board approval is requested for \$400,000 (Federal \$149,295 /State \$250,705). This includes 5 pedestrian, 2 bicycle plans, and 3 joint bicycle/pedestrian plans for a total of \$275,500 in funds. Additional funds are appropriated for State Administration.

To date, approximately \$3.5M has been allocated to 133 municipalities through this grant program. Funding for the program comes from an allocation first approved by the North Carolina General Assembly in 2003 in addition to federal funds earmarked specifically for bicycle and pedestrian planning through the Department's Transportation Planning Branch.

Approval – Recommended Supplemental Allocation of Highway Maintenance Appropriations (Fiscal Year 2012-2013)

Upon a motion by Board Member Palermo, which was seconded by Board Member Kernea, the following was approved:

On July 12, 2012 the Board of Transportation approved an allocation of Maintenance Funds in the amount of \$761,270,626 in accordance with the Joint Conference Committee Budget. Following ratification of the Budget Bill, there were two supplemental allocations – August 9, 2012 and September 6, 2012 – totaling \$426,911,883 bringing the overall allocation amount to \$1,188,182,509. There are previously unallocated funds in the amount of \$10,000,000 in each of the Primary and Secondary Systems. It is recommended that \$5,500,000 of the previously unallocated Secondary funds be allocated to compensate for the costs associated with multiple non-declared emergency site repairs. It is recommended that the remaining unallocated funds be allocated based on existing maintenance formulas.

Furthermore, \$2,736,877 has now been made available to cover Legislative increases. In addition, Safety Officers were recently transitioned from Admin to Field positions, abolishing vacant Admin positions. This resulted in \$343,625 in salary reserves to be distributed to Maintenance categories based on the percentage used for Legislative increases. Finally, there is a \$165,090 reduction in Maintenance funds due to the Retirement Rate reduction. The distribution per category is detailed in the table below:

WHEREAS, Mr. Boyette was committed to developing recreational opportunities for young men and women for over twenty years by spearheading regional, statewide and national softball tournaments in Wilson County, which brought considerable economic benefit to county and regional businesses, resulting in his induction into the National USSSA Hall of Fame; and

WHEREAS, Mr. Boyette was elected a Wilson County commissioner in 2002, was twice re-elected, and was elected vice chairman beginning in 2002 and re-elected vice chairman each year until he was elected chairman in December 2010. His service as a commissioner included the expansion and development of critical public safety services including the Sheriff's Department, emergency disaster response, the Volunteer Fire Departments' Incident Software, and the expansion of Emergency Medical Services including the location of a substation in Rock Ridge; and

WHEREAS, Mr. Boyette demonstrated vigorous support of economic development activities and generously donated his time and support to serve on boards and commissions; and

WHEREAS, Mr. Boyette demonstrated his dedication to the improvement and expansion of education opportunities by supporting funding for the Wilson County Public Schools and Wilson Community College including local financing for school construction, and was an avid supporter of high school student athletes and was recognized as such when the baseball field at Hunt High School was named in his honor; and

WHEREAS, the Wilson County Board of Commissioners endorses the naming of the bridge at the interchange at Highway 264 and Stantonsburg Road in Wilson County for Robert S. Boyette.

Now, Therefore, Be IT Resolved:

That the North Carolina Board of Transportation name the bridge at the interchange at Highway 264 and Stantonsburg Road as the *Robert S. Boyette Bridge*.

That appropriate signs be erected at a suitable time.

RESOLUTION FOR PATROLMAN LEONARD MEEKS, JR.

Upon the recommendation of the Road Naming Committee, a motion was made by Board

Member Burns, seconded by Board Member Perkins, to approve the following resolution:

WHEREAS, on December 25, 1972, North Carolina Highway Patrolman Leonard Meeks, Jr. was killed in Chatham County, about seven miles from Pittsboro, when he was en route to assist another State Trooper; and

WHEREAS, Patrolman Meeks was just thirty-two years old and is the only State Highway Patrol Officer killed in the line of duty in Chatham County; and

WHEREAS, the Chatham County Board of Commissioners requests that a bridge on U.S. 64 be named in honor of Patrolman Meeks.

Now, Therefore, Be IT Resolved:

That the North Carolina Board of Transportation names the bridge on U.S. 64 over the Rocky River east of U.S. 421 as the Patrolman Leonard Meeks, Jr. Bridge.

That appropriate signs be erected at a suitable time.

RESOLUTION FOR REVEREND GEORGE KLOSTER

Upon the recommendation of the Road Naming Committee, a motion was made by Board

Member Kernea, seconded by Board Member Palermo, to approve the following resolution:

WHEREAS, Rev. George M. Kloster was born in New York in 1943, then moved to Clayton with his family in the early 1950s; and

WHEREAS, Rev. Kloster was ordained a priest to serve in the Diocese of Raleigh, which at the time covered the entire state; and

WHEREAS, Rev. Kloster spent the next 45 years in North Carolina serving pastoral appointments in Ahoskie, Greensboro, Jefferson, Gastonia, Boone, Brevard, Murphy and Hayesville; and

WHEREAS, Rev. Kloster served the North Carolina Council of Churches (NCCC) in many areas including serving as a member of the House of Delegates, Executive Board and as its President from 1986 to 1988. He was also the recipient of the Distinguished Service Award in 1991; and

WHEREAS, Rev. Kloster led a group in Greensboro to study the shortage of affordable housing in the area that resulted in an award by the U.S. Department of Housing and Urban Development of funds to build a residence for senior and non-ambulatory persons. He later built a second housing unit which is part of Dolan Manor; and

WHEREAS, Rev. Kloster was instrumental with the Departments of Social Services in Clay and Cherokee counties in starting the Far West Families First program; and

WHEREAS, Rev. Kloster has been a leading advocate for ecumenism, social action and justice over the years in the North Carolina communities he has served as pastor; and

WHEREAS, the commitment of Rev. Kloster in church, civic and community affairs has brought honor and pride to the citizens of Clay and Cherokee Counties, it is altogether fitting and proper that a portion of highway U.S. 64 near the Clay/Cherokee County Line be named in honor of Rev. George M. Kloster.

Now, Therefore, Be It Resolved:

That the North Carolina Board of Transportation name the portion of U.S. 64 from SR 1130, Stewart Cove Road, to the William Wells bridge as the Rev. George Kloster Highway.

That appropriate signs be erected at a suitable time.
