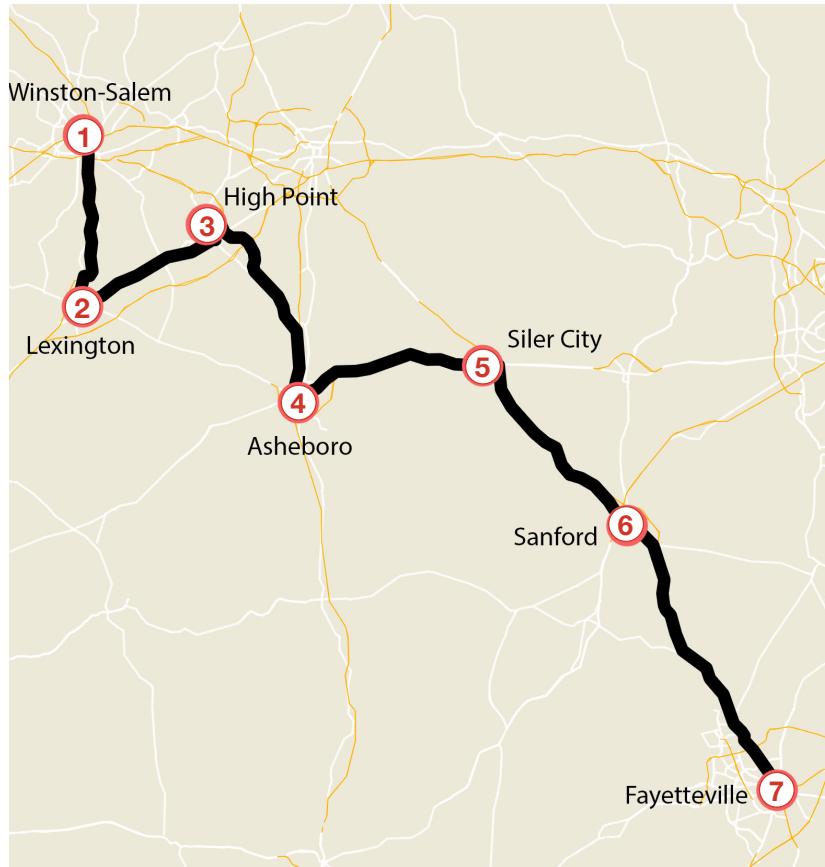


# MID-STATE EXPRESS MAP
