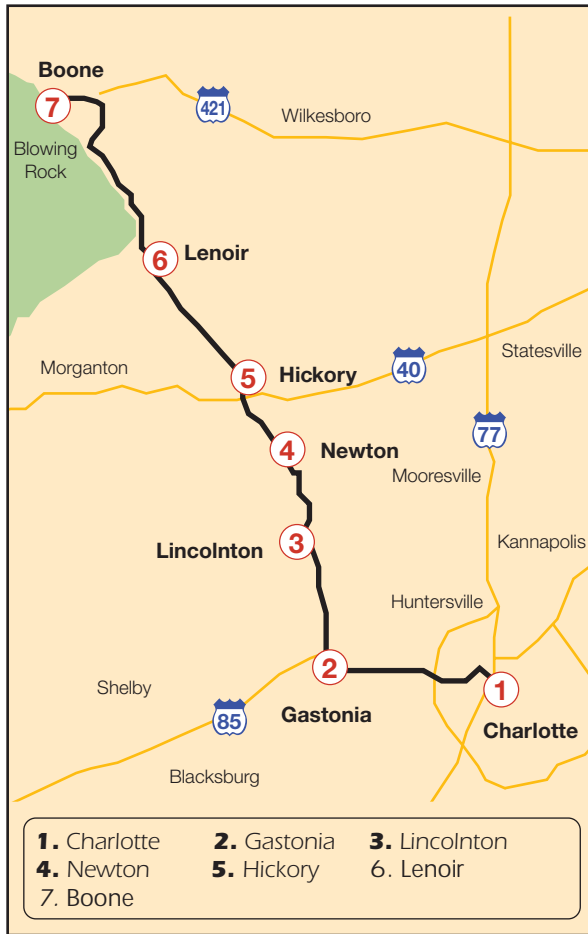


MOUNTAINEER NORTH/SOUTH MAP
