Chairman Galyon read the Ethics Statement advising any Board Member that may have a conflict of interest or appearance of conflict to abstain from participation in that particular item and to file the proper paper work with the Secretary to the Board.

### **Approval - Minutes of November 1, 2007 Board Meeting**

The minutes of the November 1, 2007 Board of Transportation Meeting were unanimously approved upon a motion by Board Member Kindley and was seconded by Board Member Perkins.

## Approval - Award of Highway Construction Contracts in the November 2007 Letting

Keller Jr. has served on numerous civic and charitable boards including the Lee County Board of Health, Environmental Health, Jury Commission, Recreation, the Bread Basket, Central Carolina Community Foundation, First Baptist Church, Cool Springs Baptist Church, Jonesboro Masonic Lodge, Sanford Shrine Club, Elks Club and a charter member of the Sanford Jaycees; and


