Conveyance of an approximate 0.16-acre residue to Jim L. Tucker and Deborah W. Tucker, the only interested adjacent owners, for the appraised value of \$1,600.00.

**Approval – Winston-Salem Urban Area MPO Comprehensive Transportation Plan**

Mike Bruff, Branch Manager of Transportation Planning, advised that the Transportation Planning Branch has worked cooperatively with the Winston-Salem Urban Area MPO on the development of a Comprehensive Transportation Plan (CTP). The Plan was adopted by the MPO on September 17, 2009, and is based on an analysis of existing and projected travel and land use, public involvement and field investigation of recommended improvements.

Accordingly, on a motion by Board Member Burrell, seconded by Board Member Perkins, Board Member Halsey abstained from voting, the Board approved the Winston-Salem Urban Area MPO Comprehensive Transportation Plan.
