## **BOARD OF TRANSPORTATION MEETING**

**September 1 – 2, 2010**

### **Call to Order**

Chairman Collier called the meeting of the Board of Transportation to order at 1:02 p.m., Wednesday, September 1, 2010 in Raleigh, North Carolina with the following members present:

Overholt, McNairy, Alford, Tulloss, Szlosberg-Landis, Ciccone, Fox, Wall, Burns, Womble, Perkins, Collett, Halsey, Proffitt, Burrell, Watts

Member White was absent.

### **Invocation**

The invocation was offered by Board Member Perkins.

### **Ethics Statement**

Chairman Collier read the Ethics Statement advising any Board Member that may have a conflict of interest or appearance of conflict to abstain from participation in that particular item and to file the proper paper work with the Secretary to the Board.

### **Approval – Minutes of August 4 - 5, 2010 Board Meeting**

The minutes of the August 4 - 5, 2010 Board of Transportation Meeting were unanimously approved upon a motion by Board Member Burrell, which was seconded by Board Member Wall.

### **Chief Operating Officer Jim Trogdon's Remarks**

Chief Operating Officer Jim Trogdon welcomed everyone to Raleigh. He informed the Board that Secretary Conti was in Little Rock, Arkansas attending the SASHTO annual meeting. At the meeting, Secretary Conti accepted a Southeast Regional Award as part of the 2010 America's Transportation Award Competition on behalf of the department. The category was "Innovative Management" and the project was the 0.6 mile widening and bridge replacement on Morganton Road in Fayetteville. The project is now a finalist for the People's Choice Award. This award is determined by online voting. Mr. Trogdon encouraged everyone to go online and cast their vote for this outstanding project. The grand prize will be presented at the AASHTO annual meeting in Biloxi, Mississippi on October 31. Mr. Trogdon congratulated Division 6 and the other staff involved with this project.

Mr. Trogdon updated the Board on the ongoing preparations due to Hurricane Earl. This hurricane is predicted to impact the Outer Banks late Thursday or early Friday and the department is making sure that bulldozers and other equipment in our coastal areas will be ready. The Department will be coordinating with divisions across the state to have supplemental crews and equipment available if necessary. Ferries have been moved to Stumpy Point and Rodanthe in case the emergency ferry route must be implemented. Our aircraft is also ready to assist as needed. Real-time information about travel conditions will be provided through a wide variety of social media, including our website, Twitter, Facebook and Flickr.

Mr. Trogdon reminded the Board of the action that would be coming up later in the meeting regarding the draft Policy to Projects Work Program. He emphasized that this document is designed to be strategic, achievable and collaborative in nature, and public input is an integral part of the process.

The Citizen Connect Forum for the North Carolina Mobility Fund has been developed to obtain input and facilitate discussion regarding the criteria we should use when choosing projects to fund through the new N.C. Mobility Fund. The month-long public comment period began August 9 and ends September 9. We hope to expand the Citizen Connect online forum to other projects in an effort to provide increased opportunities for public comment.

The Communications Office launched a revised NCDOT home page on August 18. The new streamlined and easier-to-navigate home page offers more ways to share important information with the public. It also gives top billing to the recently updated project search tool and features a second slide show where we can highlight major projects and initiatives.

Mr. Trogon informed the Board that this past month we have continued with public involvement activities for several major projects, including the proposed replacement of the Bonner Bridge over Oregon Inlet and the I-95 Corridor Planning and Finance Study. A record number of comments were received on the Bonner Bridge replacement project. Efforts also continue with obtaining feedback regarding the upgrades that are needed along I-95. Due to the volume of comments received, we have also extended the public comment period on the TIER II Draft Environmental Impact Statement for the Southeast High Speed Rail corridor between Richmond and Raleigh.

The Governor's Highway Safety Program kicked off its Labor Day "Booze It & Lose It" campaign on August 20. It runs until September 6. During last year's campaign, officers issued more than 105,370 traffic and criminal citations.

Mr. Trogon informed the Board of events that he and Secretary Conti are involved in. He also shared a video produced by our Communications Office. The video, "Drive Green, Save Green", is aimed at helping motorists save money and reduce pollution.

### **Draft Transportation Work Plan**

Chief Operating Officer Jim Trogon requested formal Board consideration to submit documents for public comment and allow work to begin on air quality conformity determinations. The Board was presented the Draft Transportation Work Plan at the August meeting and was asked to review the information. If approved by the Board, this draft plan will be released to MPOs, RPOs, local officials and other interested parties for their comment. Formal action by the Board will be requested September 2, 2010.

### **Monroe Finance Plan**

Chief Financial Officer Mark Foster presented information to the Board seeking guarantees from NCDOT for the Monroe project similar to those granted to TriEx. Mr. Foster shared information with the Board regarding the Monroe Plan of finance. A Resolution approving certain support guarantees to the Monroe Connector System in connection with bond financing by the NCTA and authorizing the Secretary to take all necessary steps in connection therewith was given to the Board. A motion was made by Board Member Overholt, which was seconded by Board Member Perkins to approve the Resolution. Mr. Foster will present the Board with additional information at the November meeting.

### **EEP's Biennial Budget Status**

Bill Gilmore with the Department of Environment and Natural Resources presented the Board with an update on the development of the EEP Biennial Budget. In June an interim budget was approved. A motion was made by Board Member Szlosberg-Landis, which was seconded by Board Member Overholt, to approve operating from the interim budget through this year. A presentation will be done in May 2011 for final budget approval.

**Approval – Allocation of Highway Fund & Highway Trust Fund Appropriations for the Secondary Road Improvement Program – FY 2010-2011**

Pursuant to the recommendation of the Secondary Roads Office, the Board concurred with the staff recommendations and delegated authority to the Secretary to approve the following:

General Statute 136-44.2A requires that there shall be annually allocated for the secondary road improvement program a sum equal to 1-3/4 cents per gallon of gasoline tax revenue from the previous fiscal year. This amount is \$ 90,827,155.25. However, \$31,593,359.00 will be reprogrammed for statewide maintenance activities in accordance with provisions of the latest biennial budget bill leaving \$ 59,233,796.25.

General Statute 136-44.5 provides that, except for Federal-Aid Programs, the Department of Transportation shall allocate all Secondary Road Improvement Funds based upon a mileage study of the total number of state maintained secondary roads in the state. This mileage study is to be completed prior to July 1 in each calendar year. Beginning in FY 2010-2011, allocations pursuant to subsections (b) and (c) shall be based on the total number of miles in the county in proportion to the total State-maintained secondary road mileage.

$$\text{County Allocation} = \text{for Secondary Road Improvements} \times \frac{\text{Statewide Appropriation}}{\text{Total number of state maintained secondary miles in state}}$$

General Statute 136-182 provides that the Highway Trust Fund allocations, beginning in fiscal year 2010-2011, shall be based on the total number of miles in the county in proportion to the total State-maintained secondary road mileage. The Trust Fund amount of \$ 85,649,158.20 is to be allocated in accordance to this provision.

Included are copies of the 2009 Secondary Road Construction Criteria, and 2009-2013 paving priority rating sheets, which are used in formulating the 100 County Programs for Improvements to the Secondary Road System presented to the county commissioners as required by North Carolina General Statute 136-44.7.

### 2011 Secondary Road Construction Criteria

1. The established 2009-13 paving priority rating system will be used to pave unpaved roads in the 100 counties.
2. The secondary road paving priorities shall include as a primary factor the availability of donated right of way, or right of way available through the bonding process allowed under 19A. NCAC 2C 0108. A secondary road will not be paved under a program or priority established by G.S. 136-44.7, regardless of position, unless necessary right of way is determined to be available by donation or bonding. Any secondary road which cannot be paved due to unavailability of donated or bonded right of way shall not be considered a first ten priority road for purposes of G.S. 136-44.7. Any road which would be in a first ten or other priority position, but for the unavailability of donated or bonded right of way, shall be reinstated to its prior position at such time as donated or bonded right of way becomes available, or as soon thereafter as reinstatement can be administratively accomplished.

3. The need to improve the unpaved roads that will not be paved into “all-weather” roads through a Spot Improvement Element. Projects in the Spot Improvement Element will be based upon a review in each county of the short sections of unpaved roads that are in need of immediate rehabilitation or reconstruction.
4. The need to replace deficient bridges on unpaved secondary roads with pipes or new structures.
5. The need to continue to address safety problems on the paved and unpaved secondary roads and at particular intersections.
6. The need to improve paved secondary roads. This would include widening, strengthening, intersection improvements, and bridge improvements/replacements.
7. The Board of Transportation recognizes the potential for assistance with funds allocated to the 100 counties for the location of new industrial manufacturing facilities should the need arise due to the limitations on the Statewide Access and Public Service Road Fund which is used to provide industrial access roads.
8. The Board of Transportation recognizes that some unpaved roads have sections that are continuing maintenance problems such as steep grades or low areas which become impassable during rainy weather. The Board of Transportation will allow paving of these sections up to a maximum length of 0.20 mile to correct the maintenance problems. Situations of this nature will be reviewed individually. Written justification for the paving by the Division Engineer will be required.

Project No. 11-IC-012 Federal and state funds are requested for the operation of two new intercity bus routes from Boone to Charlotte and from Fayetteville to Charlotte. The department issued a call for projects resulting in applications from two providers. The recommended operator of these routes is **America Charters Ltd.** (dba Coach America). Both routes would operate one round trip per day, seven days a week. Departures would be around 9:00 with arrivals around noon. Both trips would have an approximate five-hour layover before the return departure time of approximately 6:00 pm.

The two routes serve key origins/destinations of typical intercity bus riders such as students, military personnel, and individuals traveling to major medical centers. They also provide good connections with Greyhound intercity bus service in Charlotte and Fayetteville.

Coach America has estimated that the Boone-Charlotte route will transport approximately 6,000 riders annually, and the Fayetteville-Charlotte route will carry about 2,500 riders annually. The routes will be evaluated at the end of the first fiscal year to determine if ridership warrants continued operation and in order to make any necessary service adjustments.

Coach America is requesting capital funds to purchase 3 computers and 3 printers for use in this service to interline with the Greyhound network.

The project is proposed as a two-year contract (FYs 2011 and 2012), with a start date of October 1, 2010. Federal funding is from FTA's Section 5311(f) Intercity Bus Program. The department must allocate 15 percent of its annual apportionment of Section 5311 funds for non-urbanized areas to this program unless the Governor certifies that the state's intercity bus needs are being adequately met.

## Divisions 7, 9, & 11

Project No. 11-IC-011 Funds are requested for the operation of an intercity bus service between Greensboro and Boone. The recommended operator of this route is **America Charters Ltd.** (dba Coach America).

This route is currently operated as the *Mountaineer Express* by Coach America through a contract with the Piedmont Authority for Regional Transportation (PART). PART has decided not to be involved in the provision of this service in the future. This proposed action will allow the uninterrupted continuation of the service.

The route operates along US 421 with stops at Winston-Salem Transportation Center, Wake Forest Baptist Medical Center, Forsyth Hospital, Yadkinville, Wilkes Community College, Appalachian State University and Boone Mall. The service consists of two round trips daily Monday through Sunday between the hours of 5:30 AM and 9:30 PM. This route connects with services to the Greensboro Galyon Depot, Piedmont Triad International Airport, Greyhound, and Winston Salem Transportation Authority fixed route bus service. Ridership is projected to be approximately 12,000 passenger trips annually.

Coach America is also requesting capital funds to purchase 2 computers and 2 printers to interline with the Greyhound network.

The project is proposed as a two-year contract (FYs 2011 and 2012), with a start date of October 1, 2010. Federal funding is from FTA's Section 5311(f) Intercity Bus Program. The department must allocate 15 percent of its annual apportionment of Section 5311 funds for non-urbanized areas to this program unless the Governor certifies that the state's intercity bus needs are being adequately met. The route will be evaluated at the end of the first fiscal year in order to make any necessary service adjustments.
