Board of Transportation Meeting

July 6 - 7, 2011

Call to Order

Chairman Collier called the meeting of the Board of Transportation to order at 1:02 p.m. Wednesday, July 6, 2011 in Raleigh, North Carolina with the following members present:

Overholt, Alford, Tulloss, Watts, Szlosberg-Landis, Ciccone, Fox, Wall, Burns, Womble, Perkins, Halsey, Burrell

Members absent were: McNairy, Collett and Proffitt

Ethics Statement

Chairman Collier read the Ethics Statement advising any Board Member that may have a conflict of interest or appearance of conflict to abstain from participation in that particular item and to file the proper paper work with the Secretary to the Board.

Approval – Minutes of the June 2 – 3, 2011 Board Meeting

The minutes of the June 2 - 3, 2011 Board of Transportation meeting were unanimously approved upon a motion by Board Member Overholt, which was seconded by Board Member Alford.

Secretary Conti's Remarks

Secretary Conti welcomed everyone to Raleigh. He discussed the new budget that went into effect on Friday. He stated that compared to other state agencies, the budget left the department in relatively good shape. It gives us more resources for roads and bridges, which will help us work with the private sector to build and maintain a great transportation system. It also calls for us to streamline our overhead and eliminate nearly 400 positions. We will likely do that in phases over the next year. The department plans to restructure and consolidate to make us more efficient. Secretary Conti also discussed the changes the budget will have on the Ferry Division. For the first time, passengers will have to pay tolls to ride on some routes and on others that are already tolled, the fee will increase. Only two routes will remain free. The department does not know how much the tolls will be or when they will go into effect; however we will not make any tolling changes without talking to the public first.

Secretary Conti stated the General Assembly did not take action on the issue of capping the state gas tax. It is possible they will revisit this issue during the summer short session. The bi-annual rate adjustment went into effect on Friday, raising the state gas tax by 2.5 cents per gallon. This is an increase of around \$19 per year for the average driver. He stated that while the impact on the consumer is fairly minimal, the revenue generated for NCDOT is quite significant. Every penny added to the state gas tax equals about \$50 million for road maintenance and construction. If a cap is put in place, it will severely limit our revenue stream.

Secretary Conti discussed the adoption of the Policy to Projects document. This document shows over a 10-year period how the policy decisions the board makes translate into the transportation projects of tomorrow. The plan includes the new TIP. The projects listed were selected with substantial public input and prioritized based on need. The department is committed to delivering them on time and on budget 95% of the time.

Secretary Conti announced that he awarded contracts for 7 road and bridge construction projects across the state. The total cost was \$53 million. The contracts went to the lowest qualified bidders.

A top priority at NCDOT is safety. The Governor's Highway Safety Program conducted the "Click It or Ticket" campaign over the Memorial Day holiday. Law enforcement officers cited more than 12,000 drivers and passengers for seat belt and child passenger safety violations. On Monday, GHSP wrapped up "Booze It & Lose It: Operation Firecracker." Law enforcement officers held checkpoints over the July 4th holiday. The results have not been tallied; however we are sure the efforts saved lives.

Secretary Conti thanked the Board for their dedication and looks forward to the August meeting in Wilmington.

Work Program/Final TIP

Mark Tyler, Director of the Governance Office, presented information regarding the Work Program/Final TIP. It was put together with regard to the Strategic Planning framework. The bulk of the document is the Project List. The Board will be asked to approve this document on Thursday, July 7th.

Turnpike Update

David Joyner, Turnpike Authority Executive Director, presented information to the board regarding current turnpike projects. The Triangle Expressway is 60% complete and under budget. The Monroe Connector/Bypass gap funds were unaffected by legislature. They are anticipating the judge's decision regarding the lawsuit in mid-September. The Legislature removed gap funds for FY 2011-2012 for the Garden Parkway. They approved gap funds of \$17.5M for FY 2012-2013 and restored gap funds of \$35M for FY 2013-2014 and beyond.

The Legislature approved gap funds of \$15M for FY 2011-2012 and \$28M beginning FY 2014-2015 for the Mid-Currituck Bridge. Mr. Joyner also stated that Legislation mandates by April 1, 2012, implementation of tolling on 6 of 8 ferry routes. The Turnpike Authority has been charged with developing the collection system.

DMV Update

Mike Robertson, DMV Commissioner, informed the Board that DMV is working on a good format for specialty plates. They have sent the information for approval to the Highway Patrol and Department of Correction. Also, some states have the front license plate. There has been no discussion for North Carolina to start that. It would be very expensive. DMV is working with the contractor in getting a tracking system in the Driver License offices in order to be able to obtain accurate wait times. The wait time went up to 26 minutes in the first two weeks in June. The time to service was 11 minutes. They are continuing to work on the Fayetteville office.

Presentation from the Creative Corridors Coalition

Board Member Ralph Womble introduced Randle Tuttle, Chair of the Creative Corridors Coalition. Mr. Tuttle introduced other members of the coalition – Glenn Walters, Bill Davis, James Taylor, and David Smitherman. Mr. Tuttle shared information with the Board regarding the goals and background of the Creative Corridors Coalition. He then turned the presentation over to Mr. Walters who shared information regarding the community engagement as well as the 2011 efforts and process. Once complete, this project will enable Winston-Salem to stand out as a place that recognizes the value of well conceived and artful public infrastructure. The design guidelines and master plan are due August 31, 2011.

The meeting was adjourned at 2:28 p.m. until Thursday, July 7, 2011 at 9:30 a.m.

Call to Order

Invocation

The Invocation was offered by Board Member Gary Ciccone.

Logistics Task Force Update

Lt. Governor Walter Dalton, Chairman of the Governor's Logistics Task Force, presented information to the Board regarding the work the Task Force has accomplished. The mission of the Task Force is to strategically create jobs and recruit industry by developing an efficient and cost effective vision plan for the seamless movement of people, goods and information throughout the state of North Carolina. They have traveled to all seven economic regions within the fourteen DOT divisions and heard from more than 100 people representing all sectors. The Task Force approved the creation of an academic investigation into the types of inland ports or other multi-modal freight facilities that might best serve the state's respective regions. The Institute for Transportation Research and Education at NC State has served as the primary investigator for this study. Per Executive Order 32, the Task Force is required to report to the Governor every six months regarding its work. Lt. Governor Dalton also discussed that through the Task Force's work, the importance of the maritime industry was recognized. He stated that

NCDOT has entered into contract with two outside engineering firms, AECOM and URS, to complete a Maritime Strategy Study which will conclude work around February 2012.

Unified Public Engagement Process Update

Dan Thomas, Technical Services Unit Head, presented information to the Board regarding the purpose of the Unified Public Engagement Process (UPEP). The purpose of UPEP document is to consolidate NCDOT's public involvement process in response to federal requirements. It focuses on public involvement in the planning, environmental, and rail areas of NCDOT programs and guides the department's future activities for public involvement and information outreach. It must be completed and submitted to FHWA prior to their approval of the STIP in October 2011.

Extension of Charlotte Light Rail Line Presentation

Carolyn Flowers, CATS Chief Executive Officer, presented information to the Board regarding their request for the extension of the light rail blue line. Ms. Flowers shared information about the Charlotte Area Transit System and how they have grown. They are requesting NCDOT support of the LYNX Blue Line Extension Light Rail Project and NCDOT commitment of 25% of the cost of the project, subject to appropriations. Ms. Flowers presented to the Board's Multimodal committee and received a recommendation from them to present and request approval from the entire Board. A motion to grant approval was made by Board Member Womble, which was seconded by Board Member Overholt.

RESOLUTION AUTHORIZING SECRETARY OF TRANSPORTATION TO PROVIDE LETTER OF COMMITMENT FOR CHARLOTTE BLUE LINE EXTENSION LIGHT RAIL PROJECT

WHEREAS, G. S. 136-44.20 authorizes the Secretary of Transportation to enter into a State Full Funding Grant Agreement for fixed guideway projects:

WHEREAS, the Department recognizes the importance of the New Start (rail transit) projects in the Metrolina region to the region's transportation network;

WHEREAS, the Department has been a key partner in growing and sustaining transit in the region, including its financial support of the Blue Line, the state's first light rail line referred to as the LYNX;

WHEREAS, the project sponsor, the City of Charlotte, has developed a plan to extend the LYNX northeast 9.4 miles from Uptown Charlotte, the region's central business district, northeast to the campus of the University of North Carolina-Charlotte, with a projected average weekday ridership of 24,500 passenger trips;

WHEREAS, the Federal Transit Administration (FTA) approved the Blue Line Extension project preliminary engineering in November 2007;

WHEREAS, the City of Charlotte has conducted value engineering resulting in an 18% reduction in costs to an estimated cost of \$977 million, resulting in reductions in financial shares for all partners;

WHEREAS, the Federal Transit Administration (FTA) approved the Blue Line Extension project preliminary engineering in November 2007 and the project expects a Record of Decision in December 2011;

WHEREAS, the City of Charlotte has requested that the Department be a financial partner, providing 25% of the share of the projects costs through a State Full Funding Grant Agreement, subject to appropriations;

WHEREAS, the City of Charlotte has requested a Letter of Commitment from the Secretary of Transportation for 25% of the capital cost of the Blue Line Extension project, subject to appropriations, as a key component of the Final Environmental Impact Statement that will be submitted to FTA in July 2011 and the Financial Plan and Project Report for Section 5309 New Starts Project Evaluation and Rating in September 2011;

WHEREAS, the Federal Transit Administration has indicated that a letter of support from NCDOT will have a very positive impact on the Blue Line Extension project's financial commitment rating;

THEREFORE BE IT RESOLVED, IN CONSIDERATION OF THE FOREGOING, AS FOLLOWS:

That the Multimodal Committee of the North Carolina Board of Transportation recommends to the Board of Transportation approval for the Secretary of Transportation to provide a Letter of Commitment to the Mayor of Charlotte for 25% financial support for the Blue Line Extension light rail project, subject to appropriations.

ARRA Funded Rail Grants

Pat Simmons, Director of the Rail Division, presented information to the Board regarding the Piedmont Improvement Program Update. He stated there are five equipment projects totaling \$20 million. The anticipated date of completion is November 2012. There are also eight station and facility projects totaling \$37 million. The mainline grade separation project will cost \$129 million. He also discussed that there are 38 track and structure projects totaling \$364 million. Mr. Simmons shared information regarding the budget, their approach to management, delivery and construction.

Legislative Update

Legislative Liaison Beau Memory presented information to the Board regarding what to expect from the Legislature in the next couple of months. There are two special sessions expected to be called. The main focus on the first session will be on overriding vetoes and the redistricting issue. The main focus on the second session will be constitutional amendments. NCDOT staff will follow all sessions very closely and inform the Board of any actions.

Approval of the Work Program/Final TIP

After the presentation from Mark Tyler, Director of the Governance Office, on Wednesday, the staff made a recommendation for the Board to approve the Work Program/Final TIP. A motion was made by Board Member Ciccone, which was seconded by Board Member Halsey.

Ethics Reminder

Chairman Collier reminded the Board of the Ethics Statement that was read on Wednesday advising any Board Member that may have a conflict of interest or appearance of conflict to abstain from participation in that particular item and to file the proper paper work with the Secretary to the Board.

Approval of Agenda

A motion was made by Board Member Perkins, seconded by Board Member Burns, to approve the agenda items with corrections and handouts, excluding agenda items C,D,E,H and L, as they are consent items and require no Board action.

Committee Reports

TIP Committee – Board Member Ralph Womble discussed the information presented to the committee. They had presentations involving the Loop Segment Analysis by Don Voelker and Calvin Leggett discussed the Interim Definition of Urban Loops Pursuant to requirement of SL 2011-145, Section 28.34(a).

Multimodal Committee – Board Member Nina Szlosberg-Landis updated the Board on presentations to this committee. They recommended the City of Charlotte present to the Board and request approval of for the Blue Line extension. They had an update from the Aviation Division as well as a report from the Bike/Ped Division.

Environmental Planning and Policy Committee – Board Member Nina Szlosberg-Landis shared an update from Dr. Petersen from Department of Public Health, looking at the public health issues as it relates to the environment. Staff will continue to look at what we can do to make improvements.

Audit Committee – Board Member Gus Tulloss informed the Board of topics discussed during this meeting. Victor Barbour presented information on Performance Measures and Eric Boyette updated the committee on the Powell Bill, Ferry Response, Internal Audit, Single Audit Compliance, and Investigations taking place in the Office of Inspector General.

Aviation Subcommittee – Board Member Gus Tulloss discussed the topics of this meeting. Aviation Director Richard Walls presented information to the subcommittee reviewing the past year and looking ahead. Mr. Walls stated that the division is looking to have 85% of all approved projects either in the planning, construction or completion stage in the next fiscal year. They are also updating their grant process electronically to match what the Division of Public Transportation is doing.

Intergovernmental Relations Committee – Mark Tyler gave a report to the Board on what the committee discussed. The committee recommended the approval of the prioritization presented by Don Voelker. A motion was made by Board Member Wall, which was seconded by Board Member Overholt.

Resolution for Thomas A. Betts Parkway

Upon a recommendation from the Road Naming Committee, a motion was made by Board Member Tulloss, which was seconded by Board Member Wall to approve the following:

WHEREAS, Thomas A. Betts Jr. was born in Rockingham County; and

WHEREAS, Thomas A. Betts Jr. graduated from Rocky Mount Senior High School and received a bachelor of science in business administration from East Carolina University in 1967; and

WHEREAS, Thomas A. Betts Jr. was the senior development officer for RBC Centura and has more than 40 years of experience in the property and liability insurance field; and

WHEREAS, Thomas A. Betts Jr. has served his community in many ways including chairman of the North Carolina Wesleyan College Board of Trustees; treasurer of the Gateway Technology Center Board where the building is dedicated in his name in honor of his leadership and vision; treasurer and chairman of the Carolina Gateway Partnership Board of Directors; chairman of the Rocky Mount Area Chamber of Commerce; member of Nash Community College Board of Trustees; member of the Nash Health Care Systems Board of Trustees; member of the Boards

of Directors of the Planters Corporation and Centura Banks, Incorporated and member of the North Carolina Board of Transportation from 2003-2008; and

WHEREAS, Thomas A. Betts Jr. has held leadership roles in many other local and statewide business and civic endeavors and received the “Tar Heel of the Week” award from the Raleigh News and Observer in October 2003; and

WHEREAS, Thomas A. Betts Jr. is a member of Church of the Good Shepherd, former member of Vestry and former chairman of Every Member Response; and

WHEREAS, the Rocky Mount City Council requested the North Carolina Department of Transportation honor Thomas A. Betts Jr. for his selfless service and contributions to the community.

NOW, THEREFORE, BE IT RESOLVED:

WHEREAS, *Sea Level* was the name of the original ferry built by the Taylor family in 1959 to cross the Pamlico Sound between the community of Atlantic and Ocracoke Island; and

WHEREAS, the *Sea Level* was sold to the State of North Carolina in 1961 and served the route between Cedar Island and Ocracoke Island until the 1980's; and

WHEREAS, the *Sea Level* later served the Pamlico River ferry route between Aurora and Bayview in Beaufort County; and

WHEREAS, the *Sea Level* was decommissioned and sold to a private company in the late 1990's; and

WHEREAS, a new vessel is being constructed for the North Carolina Department of Transportation's Ferry Division to serve the same Pamlico Sound route as the original ferry *Sea Level*.

NOW, THEREFORE, BE IT RESOLVED:

That the North Carolina Board of Transportation, at the request of the Carteret County Board of Commissioners, name the new ferry *Sea Level*.

Section 5310 Elderly Individuals and Individuals with Disabilities Program

The goal of the Section 5310 Program is to enhance coordination of federally assisted programs and services in order to ensure elderly persons and persons with disabilities have the same right as all people to utilize public transportation facilities and services. The specific objective of Section 5310 is to provide transportation services that meet the special needs of elderly persons and persons with disabilities for whom mass transportation services are unavailable, insufficient or inappropriate.

The Public Transportation Division, through the Section 5310 Program, provides grants to nonprofit corporations and associations, public bodies approved by the state to coordinate services for elderly persons and persons with disabilities, or public bodies which certify to the Governor that no nonprofit corporation or association is readily available in an area to provide the service.

Eligible capital projects will be funded 80% by the Section 5310 program funds. The department will provide a 10% state match for the capital projects, and the remaining 10% will come from an eligible local share. The Section 5310 is unique in that some senior and disabled services are eligible for 80% federal participation.

Eligible net operating expenses will be funded 50% by the Section 5310 program funds and 50% will come from eligible local funds.

This is to request Board of Transportation approval to provide State funds totaling \$295,234 to the projects as specified below, subject to final review by the project selection committee, and to submit a Section 5310 application to the FTA in the amount of \$4,827,669 in Federal funds, enter into an agreement and provide the necessary state match.

**Section 5317
New Freedom Program**

The purpose of the Section 5317 program is to encourage services and facility improvements to address the transportation needs of persons with disabilities that go beyond those required by the Americans with Disabilities Act (ADA). New Freedom grants are intended to provide additional tools to overcome existing barriers facing persons with disabilities that are seeking integration into the work force and full participation in society.

Funds are available to support the capital and operating costs of new public transportation service targeted toward people with disabilities or public transportation alternatives that go beyond those required by the ADA. All projects funded under this program must be derived from a locally developed, coordinated public transit-human services transportation planning process and included in an approved regional plan.

Eligible capital projects will be funded 80% by FTA Section 5317 program funds. The department will provide a 10% state match for the capital projects, the remaining 10% will come from an eligible local source. Eligible operating expenses will be funded 50% by the federal program funds and 50% must come from an eligible local share.

This is to request Board of Transportation approval to provide State funds totaling \$331,062 to the projects as specified below, subject to final review by the project selection committee, and to submit a Section 5317 application to the FTA in the amount of \$1,859,291 in Federal funds, enter into an agreement and provide the necessary state match.

Program Overview: The Transportation Demand Management (TDM) Program, initiated in 2004, provides state funds to cover 50% of the administrative costs of TDM Programs across the State. The four major emphasis areas for work accomplished with the funds are getting employers designated as Best Workplaces for Commuters, conducting commuter challenge campaigns aimed at employees, promoting the on-line rideshare matching program ShareTheRideNC.org, and promoting the vanpool programs in urban areas. There are currently TDM Programs in the Triad and Charlotte areas in addition to a regional TDM program in the Triangle that encompasses 8 programs. The total amount of state funds requested for administration of these TDM programs is \$909,179. Each of the local programs a critical component in reducing the expected growth of vehicle miles traveled (VMT) by commuters.
